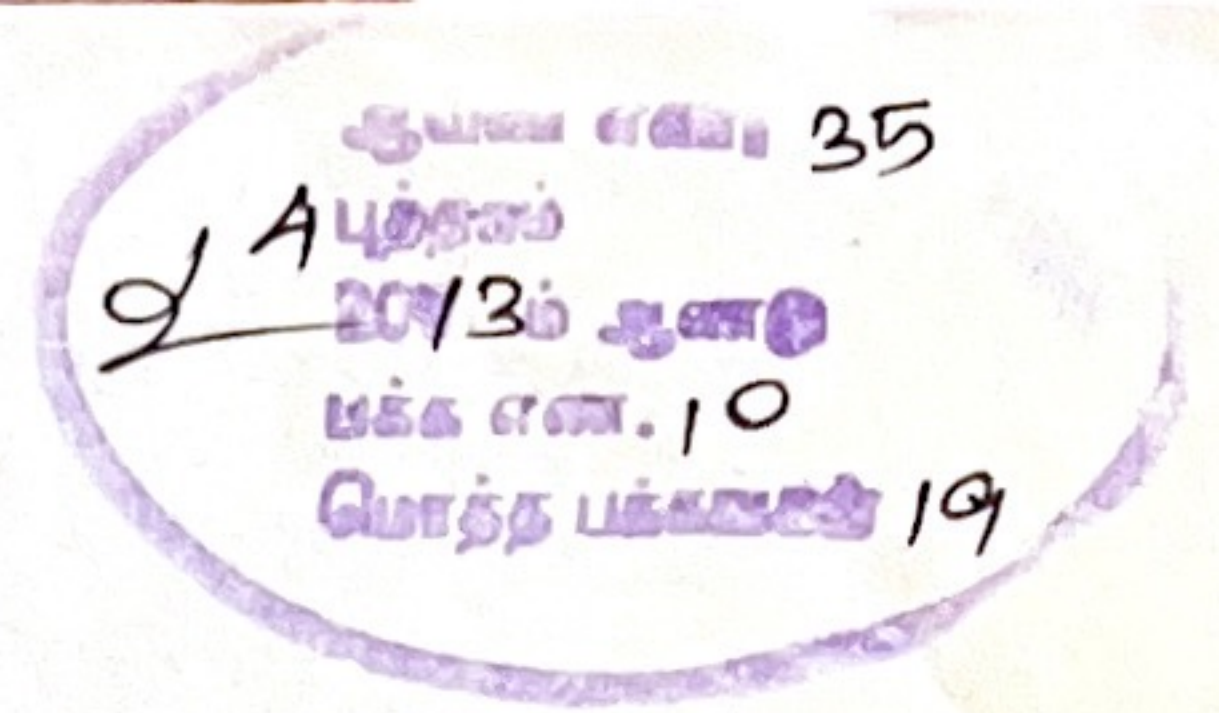




- p) To confer title on eminent personality in the field of science, education, literature, etc.,
- q) To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields. The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.
- r) To establish and / or construct and / or maintain such as Educational Institution with hostels, vocational skill training, Dispensaries clinics etc., and to offer medical service, either free or at concessional cost to the poor, sick and disabled people.
- s) To promote education in all fields and in any manner by establishing / constructing a running educational institutional trust with nominal fees or at free cost, or providing books and materials to the poor, needy students and by awarding scholarships.
- t) To organize various programmes in the field of Environment, Agriculture, Animal husbandry, Poultry training, Rural Handicrafts, etc.,
- u) To Co – ordinate and integrate such activities with Aid and Support of the Social Development agencies, Nationalized financial institutions and Government Institutions.
- v) To donate or subscribe or assist or support or coordinate with any other Educational Institutions / Trust Organizations having similar objectives or engage in the field of public services

### 5. NUMBER OF TRUSTEES:

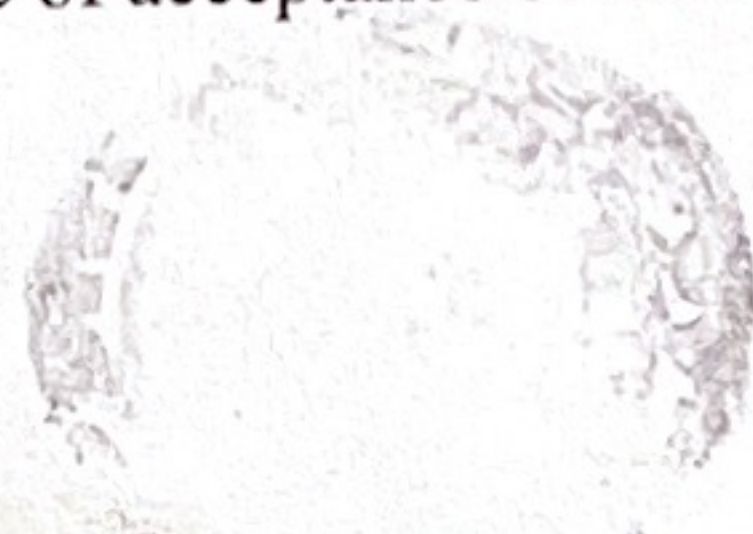
### 6. TERM OF OFFICE OF THE TRUSTEES:


One year. At every Annual General Meeting the Managing Committee will be changed and as per the board approval.

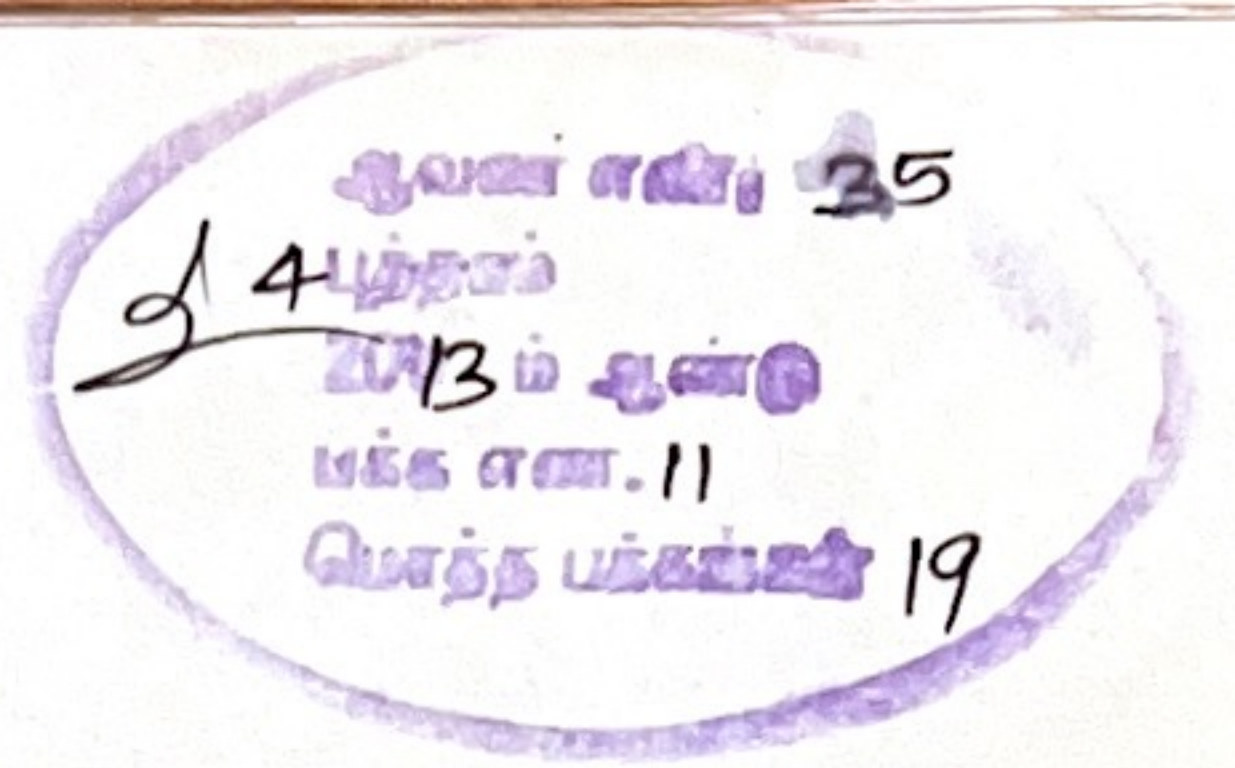
### 7. MANAGEMENT COMMITTEE:

#### POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

1. The committee shall be having rights to frame new rules and / or modify existing rules and regulations for the conduct and managing of the trust.
2. The committee shall have power to invest corpus or the income from the trust fund at their discretion in such investments as may be permitted under the Income Tax Act and other laws.
3. In future the committee shall have power to sell and dispose of any properties of the trust and apply the proceeds of such sales the expenses incurred for effecting the sale for and / or in connection with and / or in furtherance of and / or for carrying out the trust or for the purposes of any institution that may be established maintained or run by the trust.
4. The committees shall have power to levy any fees or charges from the students apprentices or others benefiting from the establishments and institutions established, maintained and / or conducted by the trust and to exempt deserving students, apprentices and others from payments, of any such fees and charges that may be fixed by the board from time to time.
5. The committee shall have power to apply for and to obtain grants-in-Aid from the Government or any other constituted authority or body or from other foreign countries who may be interested in contributing to the trust funds and settle the terms on which such grants may be obtained provided the acceptance of such of donations shall not be objectionable under any on of the provisions of the Income tax law in force at the time of acceptance of such donations.



6. All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
7. In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:
8. To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
9. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
10. To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
11. To submit proposal for grant in AID to the Local, National, International Agencies, Donors, Corporate Agencies for implementation specified interventions.
  - a. To borrow loans, to receive monies, securities or other and immovable property on behalf of the Trust.
  - b. To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
12. To award scholarship and make donations calculated to promote the objects of the Trust.
  - a. To enter into contracts, or engagements on behalf of the Trust.
  - b. To consider such proposals submitted by Sub –committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.



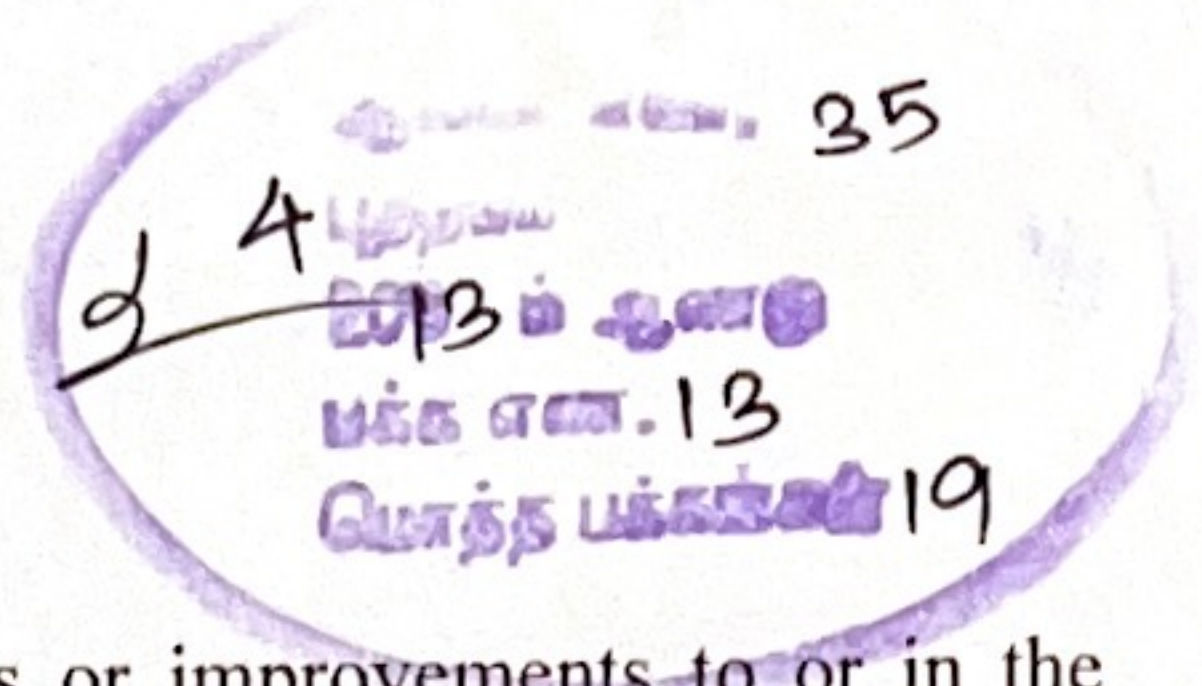

13. To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
14. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
15. To sell, transfer or otherwise dispose of any immovable or movable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
16. To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
17. To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
18. To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
19. To Modify or to make new amendment in the Bye – Laws and such other regulations as are required for achieving its objectives.
20. The Trustees not entitled to take any allowances, Salary, remuneration, etc., from the trust directly or indirectly or either cash or in kind.
21. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely.
  - a. All taxes, cess, assessments, dues and duties if any payable to the Government to any Local Administration or other public bodies in respect thereof or any part thereof.
  - b. The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
  - c. The costs of ordinary repairs and for providing any amenities to the buildings for the time to time forming part of the trust property.

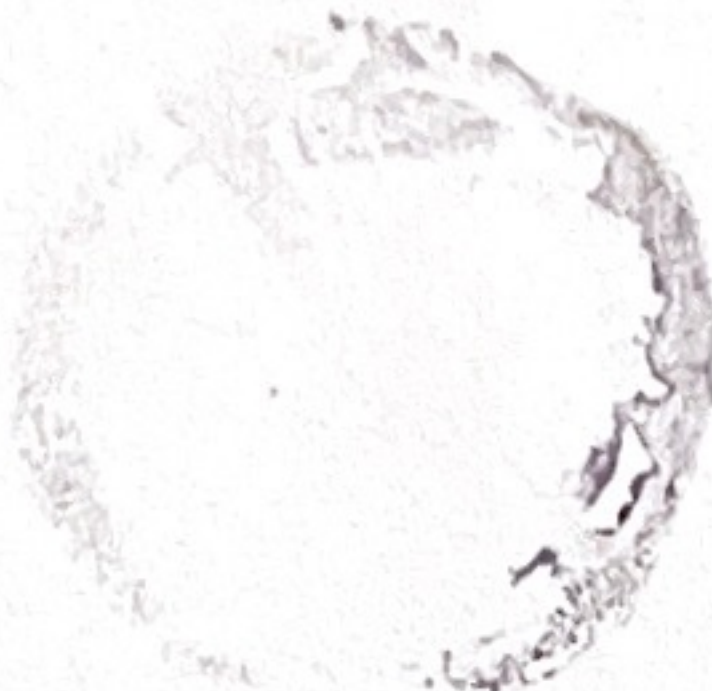

- d. The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- e. Wages and salaries of any personnel such as manager, supervisor, accountant, clerk, servant or other employees, employed by the trustees to carry out activities of Trust Programme.
- f. Cost and expenses of keeping the trust property in good condition.
- g. Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- h. The Honorarium, consultation fee and legal charges etc payable to other professionals engaged in the course of administration of the trust.
- i. All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

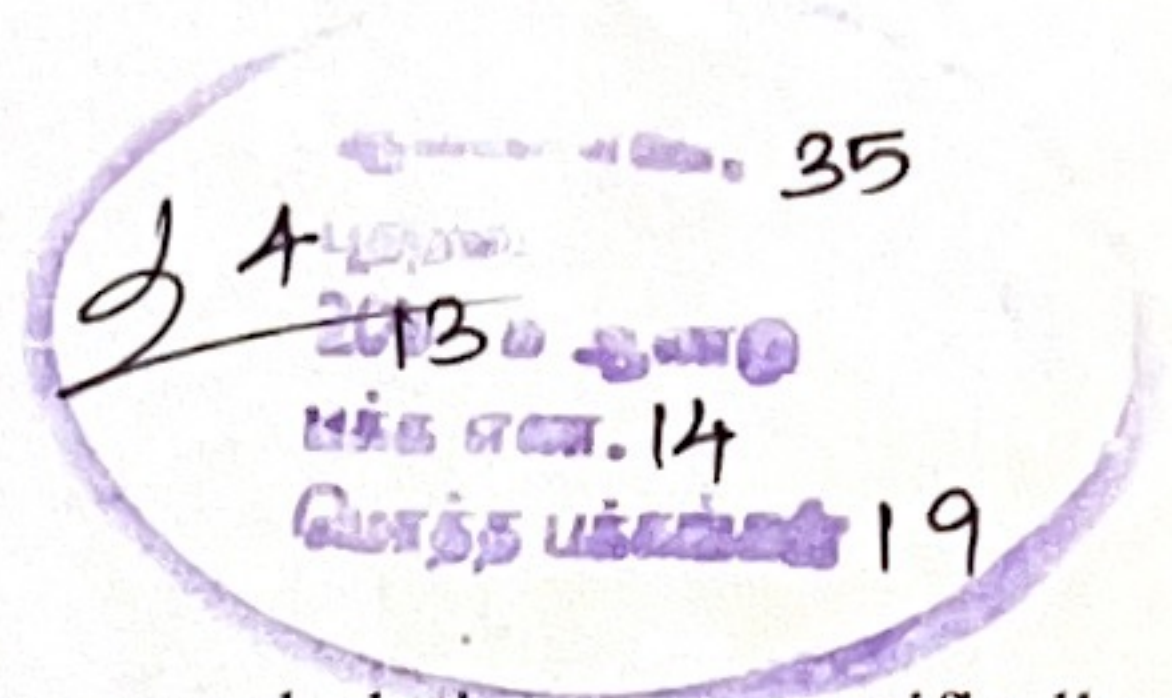
#### THE CHAIRMAN



**THE SECRETARY :**

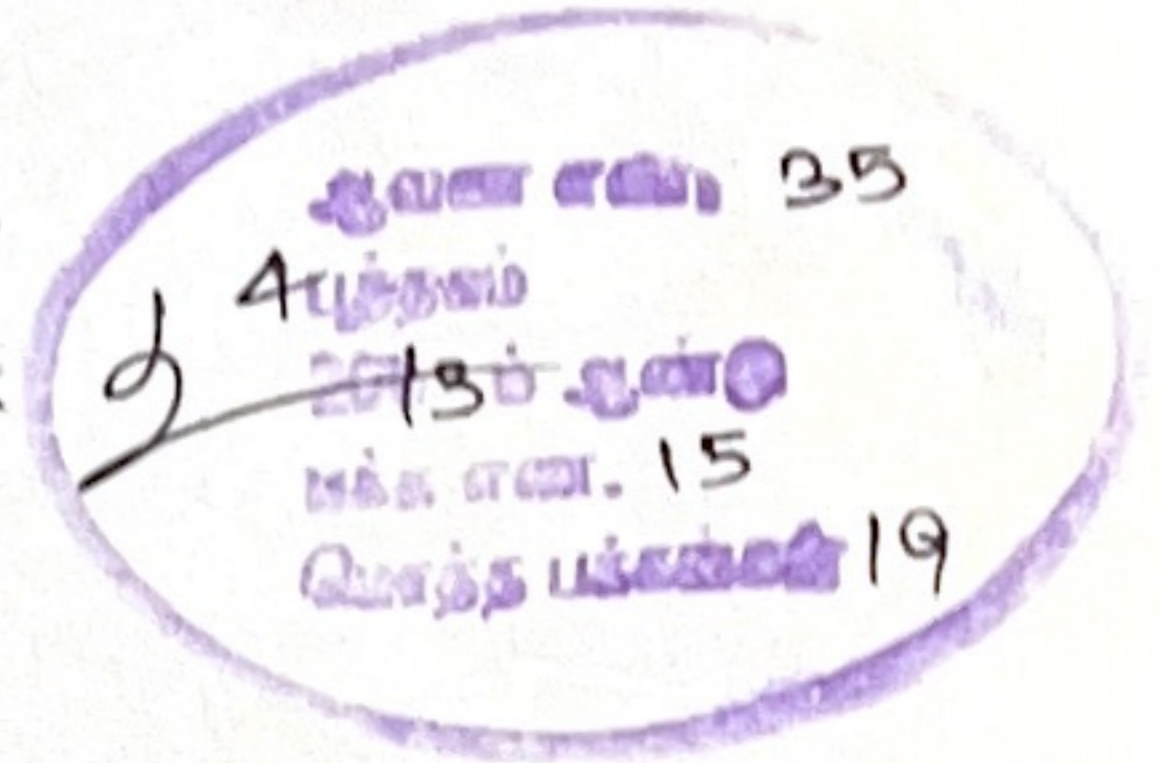
- a. The Secretary shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

- g. He shall remit subscriptions / Donations collected into bank

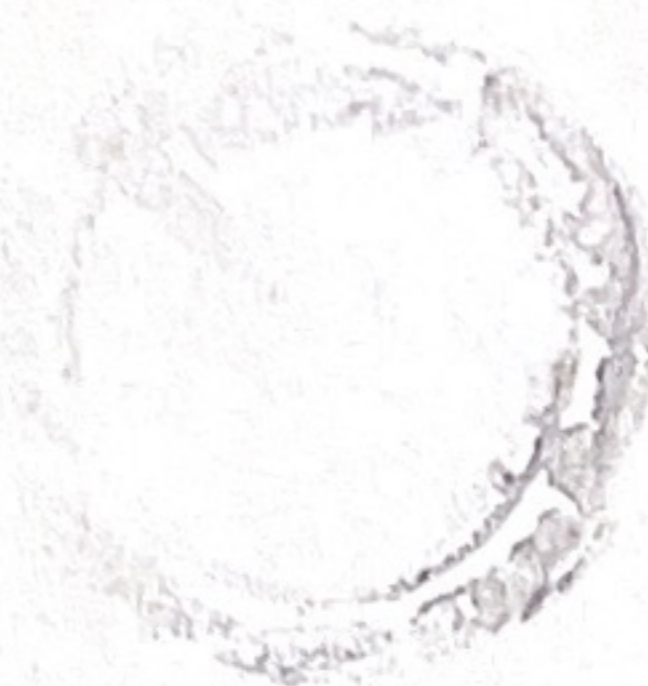
**8. VACANCIES:**

**9. TERMINATION OF OFFICE OF THE TRUSTEES:**

Trustee shall cease to hold office:

- i) if he/she dies,
- ii) if he/she resigns,
- iii) if he/she is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv) if he/she is found to have acted against the interest of the Trust.
- v) if it is unanimously decided by the Trustees specified in para(4) above that his continuation in the Office is against the interest of the Trust.
- vi) Upon expiry of the period up to which the Board of trustees have nominated the trustee.

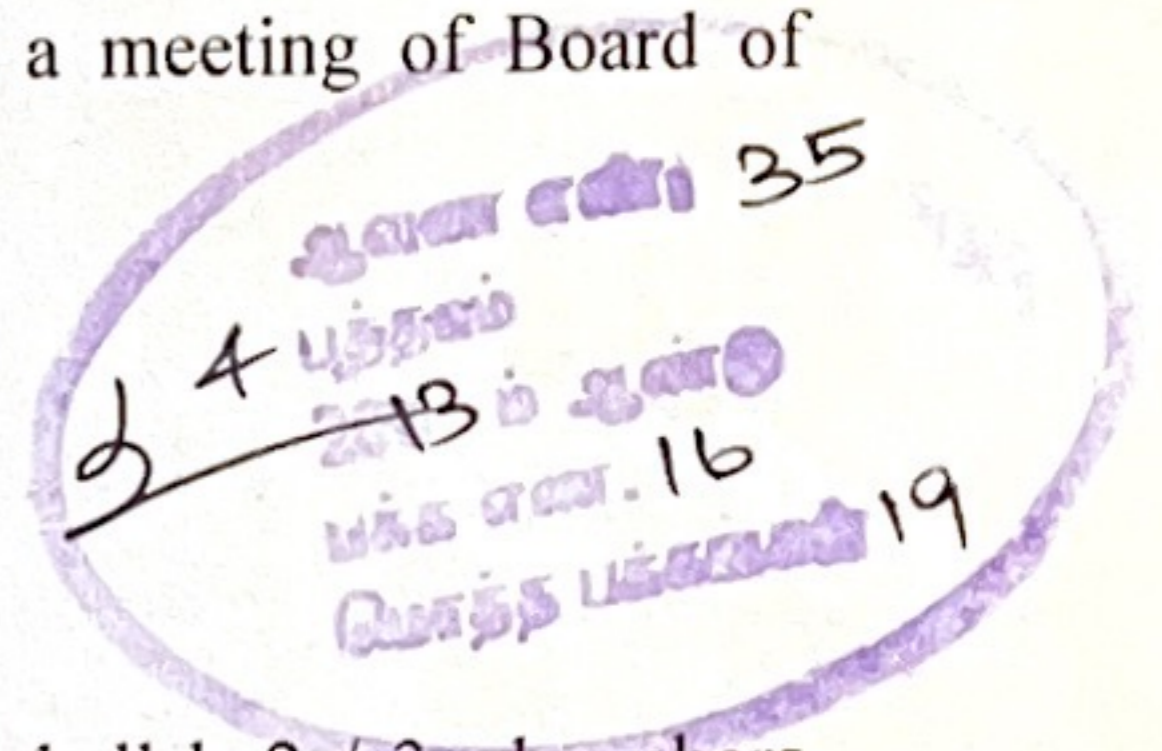
### 10. MEETING AND PROCEEDINGS OF THE TRUSTEES:

### 11. NOTICE:

15 days Notice shall ordinarily be given in writing for a meeting of Board of Trustees..

During emergency it can be covenanted with short term notice.



### 12. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be 2 / 3 rd numbers quorum is required for a meeting adjourning for want of Quorum. A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

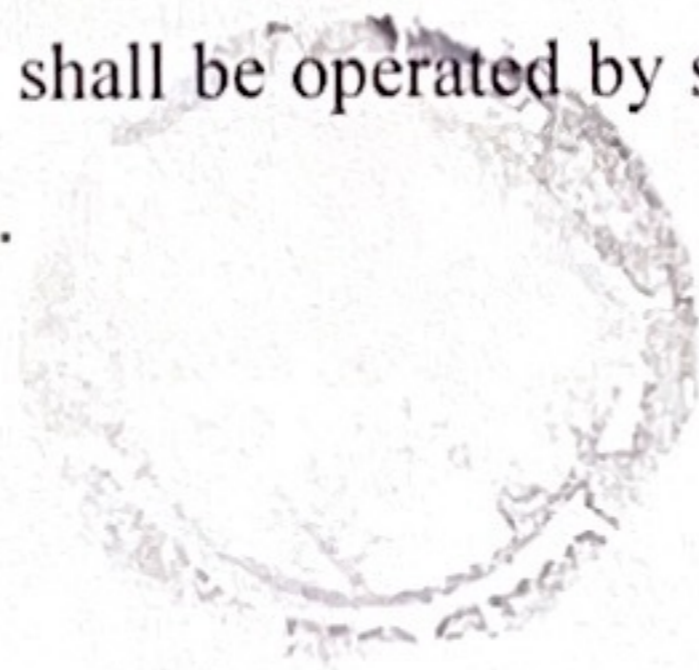
### 13. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the Board of Meeting shall have a casting vote in the event of equality of votes, in addition to his own.


### 14. BANK ACCOUNT:

(i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **ELITE EDUCATIONAL TRUST** such accounts shall be jointly operated by the any two of the trustee by passing a resolution in the Management committee meeting.

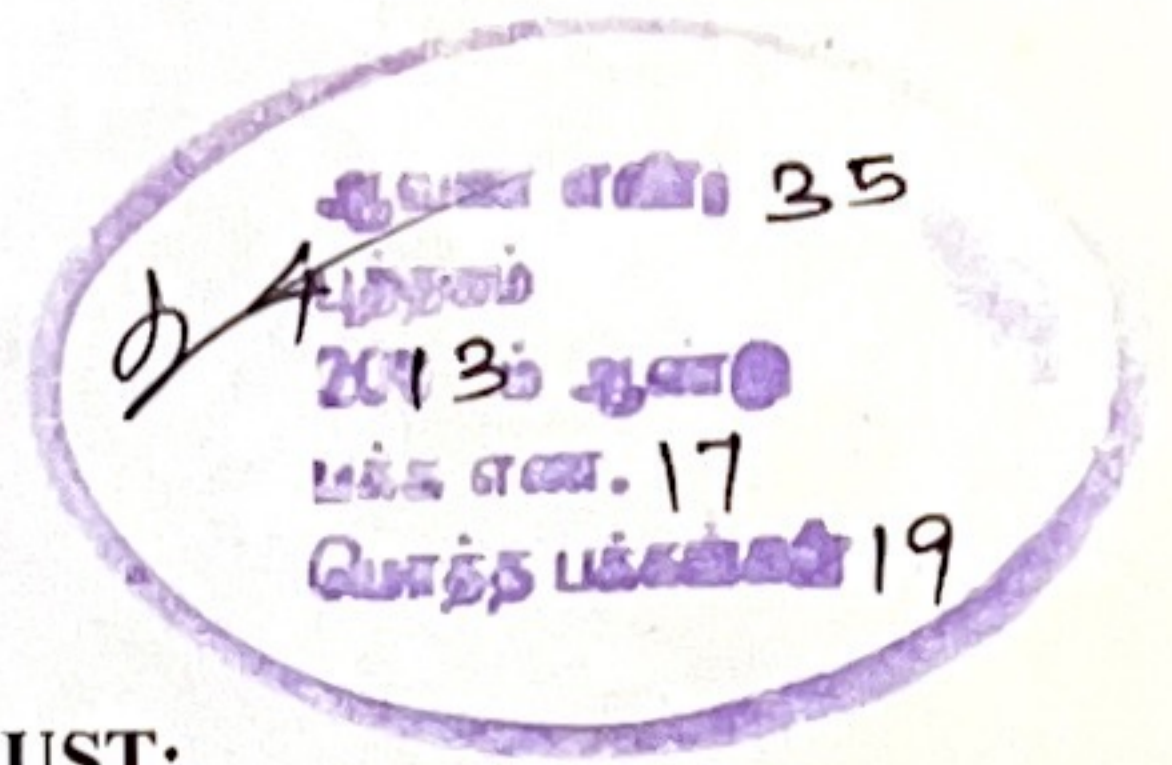

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

### 16. ACCOUNTS:

The Trustees shall maintain a Book of accounts such as record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant appointed by the Management committed for financial year ending on 31<sup>st</sup> March.

### 17. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

### 18. AMENDMENTS:

Amendments can be made at any time on need based to enhance the feasibility to achieve the objective of the trust within the rules and regulation of the Government laws with the approval of the Managing committee.

### 19. DISSOLUTION:

In the event of dissolution of winding up of the Trust the assets of the trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall transferred to other Trust, Society, Association or Institution whose objects are similar to those of this Trust.
